To motivate and facilitate the marginalized population towards a right based and gender harmonious society through mobilization of people's power and participation.





Introduction


Proud ourselves to say that Social Action Forum Irinjalakuda has completed 42 years in endeavoring various activities in collaboration with SAFPI for the integral development of poor families and bring them to the mainstream of the society. Among these four decades we could distribute around Rs.1000,00,000/- to support 19000 families. In the previous financial year we have distributed an amount of Rs. 32, 04,000/- to 291 beneficiaries. They utilized this financial assistance to improve their living conditions, such as house construction, income generating programs, medical treatment etc.

At present 221 families are being provided with a financial assistance of Rs. 900/- per month and other developmental activities. These supports help them to achieve the aspiration proposed by SAFPI. SAFI accomplishes the goal by:

- Motivating them through regional & central level meetings
- Regular monitoring visits.
- Upskill them to make use of all supports from local govt. and other people to move up their living condition.
- A special thrust is given to the human resource development by supporting them to educate their children properly.

Case Study: IR 4593 - Julie Thomas

I would like to introduce Mrs.Julie and her family who received a support from SAFPI. The family consist of Julie, Thomas, Analjo and Annmary. Their house is situated at Nadavrambu in Irinjalakuda Region, Kerala. At the time of selection they were in a midst of crisis and haven't owned property of their own. After the selection both the coordinator and animator motivated them to improve their life style. Our timely visits and guidance abetted them to overcome financial crisis and slump.

We introduced this family in the Family Action Team (FAT) meeting wherein the members from local government,



Parish Priest, Trustees, Rev. Sisters and SHG Leaders. The members of FAT are kind enough to help them to solve their problems. With their intervention the family members came forward to cultivate vegetables and fruits at their leased property. Along with this they also started a Soft drinks shop where they could sell their farm products also. All their products have high demand in the market because they used organic manure. They have done all the works by themselves and they saved the money without any extra labor cost. The local government honored them with the best farmer award in Panchayath. From their earnings they purchased three cents of land and constructed a beautiful house building of their own. They have

received a grant from the local government and a help from Social Action Forum to complete their house construction. The help received from "Save A Family Plan" was used only for generating their income. Now they have developed their vegetable shop with more products to sale. Their children are also good in studies and extracurricular activities.

Before to conclude, we would like to say that SAFI & SAFP helped them to build a better character in children. At present they are dare enough to face any problems which may occur in their future lives. To quote from their own words, this is happened because of the support we rendered to them. We could see a smile always at the face as a success of their life.

Franciscan Family Apostolate is a programme for the deficient. The goal of FFA is to provide support to the impoverished families. These families are identified and support extended so as to bring them to the main stream of our society. In the year 2019-2020, we could distribute an amount of Rs. 11,53,557/- to 48 families to meet their needs. The amount is mainly utilized for their house mend, medical treatment, and higher education of their children. The fund is mobilized as sponsorship from the good people residing in Canada, Australia and America.






DEPARTMENT OF HUMAN AND INSTITUTIONAL DEVELOPMENT (HID)

Introduction:

Base and the Back bone of the Society are relying on the Human individuals. Only through the development of the Individuals, the society can reform and develop. Women Empowerment facilitates the reduction of discriminations based on the gender classifications and capacitating women to improve more capable in financial and social status. Massive and collective movements will create more effectiveness for the fulfillment of such a move. Our Social activities are spread to the society through 137 parishes in our Diocese. Each parish activities are headed by elected






Self Help Groups:

Women SHG's are very effective tool for capacitating women and enabling them to create more opportunities for developing their personal and family status. This will ensue to develop their social and economic status too. Now SAFI has 329(includes 20Men's groups) active and effective SHG's consists of 5624 families. These SHG's are guided by elected Parish Leaders from in each Parish. There will be 10 Federation Leaders, elected from each Forane, to lead the Parish Leaders.

Joint Liability Groups:

Four or Five members from a Self Help Group come together and form a Joint Liability Group which aims at some additional Income Generation. These groups are registered with SAFI. Under the supervision and control of SAFI, these groups are eligible to get loan from Bank and invest in their Income Generating activity. Now there are 564 JLG units functioning under the leadership of SAFI. With the financial support of Bank of India, 333 JLG groups availed loan of Rs.10.05 crores, to utilize in different Income Generating Programs. Many of them engaged in Agriculture and allied activities. Our animators used to visit these units and guide the members in their activities. We



promote saving mentality among the members by initiating them to join in the Recurring Deposit Scheme at the Bank. We are also supporting 20 Men's Joint Liability Groups.

Parish Leaders And Federation Leaders:



As the tenure of the existing body of the Parish leaders and Federation Leaders were exhausted during this year, new leaders were elected. The newly elected leaders will take charge of their office as on 01st April 2020.



Christmas Cake Sale:

As an Income Generating Program for SHG's, SAFI arranged Christmas Cake Sales Campaign during the period of Christmas. The campaign also extended to the other organizations, attached to the Parish churches, and benefited them. Total sales during the period for cake was Rs.2,56,050 and the total quantity was 1,363.50kgs.

SHG / JLG Auditing:

Our Animators conducted the Internal Audit for 309 Women Self Help Groups and 20 Men Self Help Groups, for the

financial year 2018-19. Auditing for 564 JLG's were also completed for the period of 2018-19.





Gramasree's of Social Action Forum Irinjalakuda organized The International Women's Day celebrations on 10th March 2020 at SAFI auditorium. The program was inaugurated by Mrs.Krishna Pushkaran Administrator Sakhi One Stop Center Irinjalakuda, and presided by Msgr. Jose Manialy.



It brought together about two hundred lady delegates of SHG's. SAFI honored Dr.Winona Varghese(KCBC award winner for charity), Ms. Nimisha K.S(sports), Mrs.Soumya Biju(kidney donor), Mrs.Suma Janardhanan (agriculture), Mrs. Rinu Shanto(kidney donor) for their achievements and services.

An interaction section was conducted in the subject of "importance of menstrual cleanliness", lead by Mr.Jinoj, GM Wager Group.

Seminar

On February 20th 2020, KSSF director Fr.George Vettukattil & team visited SAFI and conducted a seminar about "orientation of Key strategic Pillars & Catholic Social Teachings".

Professional Education: SAFI launched 'Professional Education Scholarship Scheme' in 1997 and continues this scheme through providing professional educational support to the economically backward families. During the reporting year an amount of Rs. 6,50,000/- was distributed among 160 deserving students.

Free Entrance Coaching: With a sincere desire to create professionals, SAFI is providing free entrance coaching to 25 students from economically poor families every year, at the institutes



of Professor P.C. Thomas's classess. Social Action Forum Irinjalakuda is extremely thankful to Professor P.C. Thomas for his social concern in providing opportunities to deserving brilliant students to professionalism.

Prakruthi offers opportunities to observe and practice diverse and innovative activities. Through farmer collectives, the model is formulated in farms. Prakruthi aims how to make agriculture profitable and provide the necessary environmental protection for the next generation. Farming and dairy farming is an example for those who think they are suffering and loss. Prakruthi Agricultural Nursery's ideal Dairy Farm and livestock protection then recognized as a district-level farm school by the Department of Animal Husbandry. It has also been able to make a big move in dairy farming. Kitchen and medicinal garden and cattle are the prosperity, income and health of Kerala families are also an advantage, that today's masses are able to harmonize with the idea of Prakruthi. A dairy farm with 30 cows, goat farm with 80 goats are a refreshment for those who are looking to withdraw from the area.

JALANIDHI-PHASE II – SUSTAINABLE DRINKING WATER SUPPLY AND SANITATION.

About Jalanidhi....

Sustainable supply of Drinking water and proper sanitation is still lagging behind in all the districts of Kerala. Breaking the nutshell of safe drinking water scarcity is a very crucial problem in all parts of our State. Here arises the importance of Jalanidhi Projects. These projects are financed by World Bank. The principal objective of the Jalanidhi –II programme



is to assist Government of Kerala in increasing the access of rural communities to improve and sustainable safe drinking water supply and sanitation. The project has to be implemented through the concerned Grama Panchayath and the Beneficiary Groups. To provide technical, capacity building, social development, financial & accounting, and procurement support to Grama Panchayath and Beneficiary Group, a Supporting Organization will be selected.

Considering our previous experience, Social Action Forum Irinjalakuda had been selected as Supporting Organization for implementation of Jalanidhi –II, Rural Water Supply and Sanitation Project with Beneficiary Participation at Ozhur Gramma Panchayath in Malapuram Dt. As supporting organization, we entered into the agreement, with Ozhur Grama panchayath, as on 2nd July, 2013.

Achievements so far.....

Scheme Level Executive Committee Formed for the overall supervision of the Project. We established an Office at Ozhur with required staff. Total estimate for the project was Rs.9,70,00,000/ - and our S O payment is at 8.05 % of the project cost ie



Rs.78,08,500/- . S.O. payment received so far Rs.68,42,564/- Now the project is in its final stage. Construction of Booster Tanks and Outlet Tanks were completed in 2019. Ozhur G.P. has 2 overhead tanks. One tank is erected at Nirappil, with a storage capacity of 14.7 lakh liters of water and the other at Vellachal with a capacity of 25000 liters of water and ready for operation. Pipe laying of 151 kms were completed. Total estimated House hold connections were 3300 and all the connections were executed. Trial run of water through the laid pipes were going on.

Exit from the Project....

After successful inspection of the works carried out, we, as Support Organization will hand over the project to the

Scheme Level Executive Committee for the post implementation operations. For the functioning of the SLEC, furnished and fully equipped office is ready for occupation.

The jalanidhi-II project has been successfully completed by S O (SAFI) with the support from Ozhur Grama panchayath, Jalanidhi, and KRWSA.





JEEVAN MADHUR MICRO INSURANCE SCHEME


In 2008 with the vision of providing life insurance protection and develop the habit of saving money , Social Action Forum Irinjalakuda in collaboration with Life Insurance Corporation of India, had successfully launched this program named "Jeevan Madhur". As per the agreement with LIC, SAFI could appoint many poor ladies from the society, as sub agents throughout the region for conjoin the policy holders and collecting the premiums. Through these activities they are getting an income as agent commission.

The tenure of this Jeevan Madhur insurance scheme is optional from 5 to 15 years. The quarterly premium payable range is Rs.250 to Rs.500 and the sum assured vary from Rs.5,000 to Rs.30,000. The insurance policy covers benefits including cases of natural death, accidental death and permanent disabilities caused by accidents. If there isn't any claim during the policy period, the sum assured will be refunded on maturity of the policy along with bonus accrued thereon.

During the period 2019-20, 197 policies were matured or surrendered and settled one death claim

benefits. In this period, SAFI conducted a program for revival of policies without any late fee and 79 policy holders availed this facility.

For this period SAFI received RS.77,086 from LIC and paid Rs.63,684 to sub agents as commission.

Federal Ashwas Financial Literacy Centre, Irinjalakuda



Federal Ashwas Financial Literacy Centre at Irinjalakuda is functioning since 2012 with the active support and co operation of NGO Partner, Social Action Forum Irinjalakuda. This Centre is an initiative of Reserve bank Of India under its Financial Inclusion Programme and the sponsor bank is Federal Bank Limited.

This Centre conducts camp, provide education and training programe for farmers, MSMEs, school children, senior citizens, Self Help Groups etc and also provides financial counselling to individuals. It provides consciousness on various financial products, services, schemes available in the financial/ banking sector, Digital Banking, need for savings, family budgeting, availing need based credit facilities, maintaining good credit score, need for prompt repayment of loans, how to lodge complaints to the banks and





Banking Ombudsman etc to the common people, especially the weaker section of the society.

During the year 2019 -20, the centre was able to conduct 90 meetings/camps to 2900 beneficiaries, 30 credit counseling to individuals and celebrated Financial Literacy Week in February 2020.

Programs at a glance 2019-2020

On 08th Nov 2019 a Seminar was conducted at Social Action Forum, Irinjalakuda. Fr. Varghese Konthuruthy inaugurated the function and Sr. Rosemary delivered a class on Oncology. The programme was attended by 86 volunteers.

62 volunteers gathered at SAFI auditorium to participate in the motivation class led by Rev. Fr. Jinu Vennattuparambil on 30th Nov 2019.



Navajeevan programme

(Building Resilient Communities through Recovery support to Flood and Landslides affected communities in Kerala)



In the aftermath of the Kerala Floods of 2018, an emerging and pressing need for Disaster Preparedness in Kerala was observed. The tragedy of 2018 was sudden, and people were not expected or prepared for the impacts of the disaster. As a part of emergency relief, response and recovery, several humanitarian organizations, NGOs, government and well-wishers come forward to support the ailing population. We received massive support for rebuilding the loses occurred due to the flood. However, in this context, it is also important to form groups of self-sufficient, well-prepared communities who

can fight and face future disasters. Take this aspect in mind, now it is time to transform these communities into resilient communities who are aware and prepared to face and fight future disasters.

In order to make the concept fruitful, Caritas India, acclaimed the second largest humanitarian network globally, as well as the social wing of the Catholic Church in India, along with Social Action Forum Irinjalakuda aims for an ambitious project. Muriyad panchayath in Thrissur Dt. is a Risk & Disaster prone area. With the aim of forming self-sufficient and well prepared groups, 10 wards were selected from the Muriyad Panchayath and project started on 9th August 2019.

Overall Objective

To capacitate and empower all category of people in 10 vulnerable panchayat wards, with little or no capacity to withstand the calamities, through resilience building and disaster awareness programmes.

Specific Objectives:

- To create a concrete group of Caritas Samaritans (Caritas India's official volunteer army) in each of the 10 selected panchayat wards
- To enrich the disaster knowledge of communities and create awareness about the need for disaster preparedness programmes
- To build an army of first responders through the formation of Disaster Task Forces
- To prepare a Participatory Ward Level Disaster Preparedness and Response Plan
- To create platforms for interaction with local and state administration and to integrate the ward level plans into local level panchayat development plans

List of activities

- PDRA at the village level (VCA analysis).
- Formation of Village Disaster Management Committees.
- Development of village contingency and development plan and integration in the Panchayat Annual Plan.
- Formation and Strengthening of Village/cluster level Task force-Early Warning, Search & Rescue, and First Aid & Camp Management.
- Training of first responders.
- Sensitization and Training on Rights & Entitlements on DRR, DM Policy.
- Conduct school level DRR activities with children- Mock Drills, Awareness on Disaster, capacity building of school children on first aid.
- End-line and documentation of good practices and dissemination.
- Half Yearly review meeting and capacity building of volunteers.
- Coordination and advocacy.

Process adopted to implement Project


Initially, we arranged meeting with Deputy Collector Thrissur on 4/ 10/2019 and discussed about Disaster Risk Reduction Programme (Navajeevan programme).

Arranged meeting with Panchayath President, Block members and ward members and discussed in detail about Navajeevan programme and requested their active participation for the implementation of the programme.

With the support of these leaders, we arranged ward wise meeting in 10 selected wards and we collected social, economical, cultural details.

During the reporting year we have conducted Participatory Disaster Risk Assessment at selected 10 wards of Muriyad Gramma panchayath. Programme Cordinator Mrs. Baby Joy attended the Training programmes on the subject, at Carithas India, State Office, Ernakulam on 22nd October 2019 and at Alleppey Diocese Service Society office on 12th November 2019.

Evaluation purpose & process


The incessant rainfall in different parts of the sate in July 2019 have triggered flooding and land slides. The SAFI prepared a project in collaboration with Caritas India to assist restoring physical infrastructure damaged by the disaster in the region.

SAFI prepared the project report in accordance with Caritas India guidelines. The evaluation draws upon a review of project documents and other relevant studies, and discussions with parish coordinators. It incorporates the result of SAFI official's field inspection in the site.



Expected results

The Project was expected to restore economic activity by rehabilitating public physical infrastructure facilities. In the long term, the Project's impact was expected to be demonstrated in (i) reduced poverty and (ii) assistance to the affected people to return social and economic life to normal conditions while sustaining general economic activities in the affected regions.




Cost of project

Total cost for the project was Rs.75,47,380. Among this Rs.49,20,000 spent for house maintenance, Rs.12,95,000 spent for arranging sanitization facilities for houses, and Rs.8,08,707 spent for providing livelihood items for families. Total administration cost for the project is Rs.5,23,673.

- I) Shelter Sector: constructed or renovated 82 houses.
- II) Wash Sector: arranged sanitization facilities for 70 houses
- III) Livelihood Sector: provided livelihood items for 222 families.

DEPARTMENT OF REHABILITATION

SAFI empowered parents in caring children with disabilities (CWDs) at their home with love and affection. Rehabilitation work undertaken by SAFI is subdivided into two programs – Community Based Rehabilitation (CBR) and Institution Based Rehabilitation (IBR).



1. Community Based Rehabilitation (CBR)

The Community Based Rehabilitation program is sponsored by Liliane Fonds – a Netherland based organization through its strategic partner organization – Catholic Health Assosiation of India – Liliane Fonds (CHAI-LF) Secunderabad aiming at children/youngsters with disabilities under the age group of 25 years.

We supported 114 differently abled children for their Education including Higher & University Education, Health and Livelihood with a financial assistance worth Rs 607,316/- during the period under the report with the help of CHAl-LF. In the year 2019-2020, we conducted two Enabling Enviornment (EE) Programs for Parents of CWDs/PWDs at Irinjalakuda and Mala. The first EE program was conducted at Social Forum Irinjalakuda on 12th Dec, 2019. 105 parents of CWDs/PWDs participated in this program. The second program was conducted at Mala Block on 08th Jan, 2020 and 82 parents participated in the program. The ICDS officials and Anganawadi workers had extended their services for finding out and communicating the beneficiaries residing at their respective jurisdictional areas. Experienced and qualified resource persons lead the awareness classes which were attractive and benefitted the beneficiaries. The following subjects were covered during the programs.

- a) Protection of Child Rights
- b) Rights of children with disabilities
- c) Elimination of physical and attitudinal barriers of CWDs
- d) Benefits and different welfare schemes being provided to CWDs/PWDs by State and Cental Governments




Fig. Graphical view of the support provided to such children





2. Institution Based Rehabilitation (IBR)

SAFI is making all efforts to educate parents of CWDs whose children are studying in schools and entitled to get educational scholarships as admissible to children with different categories of disabilities through their respective Gramapanchayaths/ Municipalities without any disparity as prescribed in the Government orders from time to time. We do appreciate Thrissur District Social Justice Officials for helping SAFI in its developmental endeavours for CWDs. The Government has different programs for persons with disabilities (PWDs) like monthly disability pension, scholarships to CWDs attending schools, job opportunities, job oriented courses, scholarships to CWDs, different insurance schemes, projects on cochlear implantation, "snehasparsam" cancer security and "Thalolam" – a scheme for providing financial assistance to children below 18 years for diseases like Heart, Vin born autism and providing different aids needed by persons with disabilities.

Inorder to cater the special needs of differently abled children, SAFI has established two Special Schools for mentally challenged namely Ashanilayam Kottanellur and Santhome Edamukku, Kodungallur. The special schools provide all special needs of over 150 special children. Ashanilayam Special School Kottanellur was established in 1998 and Santhome Special School Edamukku, Kodungallur in 2014 both managed by Social Action Forum Irinjalakuda. These institutions are functioning well within the limited resources under IBR program of SAFI. While a total of 80 children with mental disabilities are being cared for at Ashanilayam by 13 teachers, 72 are being cared for at Santhome by 9 teachers. They are being provided with elementary education, activities for daily living, skill development, vocational training and different therapeutics on need basis under the IBR program.

a) Ashanilayam-Special School for Mentally Challenged: The special school provides self help skills, activities of daily living, occupational, physiotherapy & horticulture therapies and training on vocational, skills, activities for daily living and other assistance as per need in addition to Elementary education. The special school is a registered institution under the PWD Act bearing No. 555/17/2019 (Renewed) dated 06-12-2019 with the State Government of Kerala. All the teachers were provided with capacity enhancement training on managing the children with mental

disabilities and ensured optimum utilization of available manpower as per the syllabus of the school. The special school has a hostel known as **Kripabhavan**. 14 students of the special school are being cared at the Hostel. Horticulture therapy is unique to Ashanilayam special school and the school compound itself is flourished with plants and herbal bushes of bio-agriculture nursery. This therapy helps children to live in an environment of nature and enjoy pure and fresh air. The school celebrated its Annual Day on24th February 2020. All students with disabilities were trained to perform Variety entertainments in one or more items. The special school also opened a special vocational training centre of the school with support from CSR Federal Bank.

b) Santhome Special School – Kodungallur - SAFI established another special school namely Santhome, at Edamukku, Kodungallur, realizing the presence of large number of children who are mentally challenged in Kodungallur Municipality and the adjacent Panchayaths. The land for the special school was provided by the Diocese of Irinjalakuda. A new special school building has been built with super structure and the special school is fully functional with all necessary infrastructure and amenities with effect from 01-06-2017. The special school is a registered institution under the PWD Act bearing No. 1009/15/2018(Renewed wef 16.11.2018) with the State Government of Kerala.



Visit By Chai-Lf Team To Partner Organization-SAFI.

Mr.Raju, Assistant Programme officer of CHAI-LF and Mr.Rajasekar, Accounts department CHAI, Seconderabad visited Partner Organization, SAFI from 12th—14th February 2020. They carried out field visits to houses of children with disabilities on 13th and visited office on 14th February and expressed their satisfaction.

3. National Trust

Social Action Forum Irinjalakuda is a registered NGO with National Trust vide Registration No. KSOC16515653556 dated 30-03-2017 under section 12 (4) of the act for a period of 5 years from 13-02-

2017 to 14-02-2022. SAFI being a facilitator for the rehabilitation of disabilities, The National Trust is supporting this organization for the integral development of children with disabilities and activities associated with rehabilitation of children with special needs.

SANJO SADAN AYURVEDIC INTEGRATED REHABILITATION CENTRE FOR ADDICTS - ANANDAPURAM



Addiction to Psychoactive substances is the most dreadful epidemic of the 21st century affecting mostly the younger generation who are craving for the pleasure of life. This not only destroys our rich cultural heritage, but also the sanctity and stability of our family relations, since this addiction affect the normal thinking and behavior pattern of an individual. To fight against this social epidemic, Navachaithanya has started its first counseling cum awareness centre at Aloor in March 1991. For being in this field for a few years, we understood that the treatment and the rehabilitation are the two

inevitable stages of De – addiction. Thus we have started a De-addiction cum rehabilitation centre of 15 bedded hospital at Anandapuram in September 1994.

During the last 25 years of its service, 8806 addicts and their families were given treatment and counseling services. Most of the patients were motivated to this centre by our Ex-addicts, social workers and also from the Navachaithanya De-addiction Camps conducted every month by our Drug Awareness Counseling Centre at Aloor. Thus we demanded for the treatment and counseling services for alcoholics and drug addicts. Due to lack of facilities we are forced to convert our 15 bedded hospitals to 30 bedded hospitals from September 2000 onwards by taking an adjacent building for rent and also by appointing more staff.

Treatment Procedures:

De-addiction Treatment: Treatment Schedule mainly consists of Medicines, Counselling, Awareness classes & activities, Therapies and Follow Up.

Medicines: For the betterment of patients we provide the physician, Psychiatrist, Psychologist, Psychiatric Social Workers and Ayurvedic Doctor. We give 90 days medicines which consist mainly of Ayurvedic packages ie, Nasyam, Thalam, Pichu and Dharas. Ayurvedic treatment includes Herboplex Capsule, Oil Bath, Drakshadikashayam for Kidney and Liver Purification, and Eladi candy and Bigzig for minimizing the smoking tendency. In order to get a better impact for the Ayurvedic treatment vegetarian food was served.

Counselling: The centre provides lifelong counselling Services. It includes individual counselling, Spiritual Counselling, Marital Counselling and Family Counselling to the clients' Parents, Family members and their spouses.

Awareness Programme and Therapies: These sessions were given to Patients who have to stay at this centre for 31 days depending on their recovery period. It includes classes, Group interactions, prayer therapy, Music therapy, group therapy, diary writing and evaluation. Besides these physical and intellectual programmes we do have Yoga, Meditation, exercises, Reading, indoor and Outdoor games.

Follow Up: Discharged patients are given lifelong follow up according to each ones requirement .This centre also maintains constant contact with the Ex patients through letters, phone-calls, Home visits and also through Navachaithanya Publications. Occasionally we organize follow up gatherings besides classes and seminars for their spouses and children.

Referral Camps: Most of the Ex patients are referred to one – week De- addiction camps at Navachaithanya counseling centre, Aloor. Where they are given rigorous training on almost all aspects of life in order to replant them to the normal stream of life. So far more than 3296 patients were referred to De Addiction camp. Acute Psychiatric cases are referred to Sacred Heart Hospital Pullur.

A.A Groups: The Sobers are made members of their local A.A. Groups. They meet together once in a week to share their experiences, achievements and also the problems they are facing daily. Navachaithanya has already formed about 38 A.A Groups in between Kozhikode and Ernakulam District for the former patients.

Rehabilitation: Even after the treatment the patients who are neither accepted by their families nor have the courage to face their previous surroundings are allowed to stay for a while at the centre until they get the confidence to stand on their feet. They are also helped to get a new job. We have so far rehabilited 745 Ex addicts.

Through the monthly publications 'Navachaithanya Bulletin', the day to day programmes and activities of Sanjo sadan are made known to its A.A Group members and well wishers. The Bulletin also carries articles on Alcoholism, Drug abuse &Addiction, prevention and treatment of addictions, and other topics.
